NEW GOVERNORS' CAMP FLEX POLICY FOR OCTOBER 2020 AMENDMENTS

This applies to confirmed bookings we are currently holding and is not applicable to any new bookings.

The following is the **Governors' | Flex Policy** for our **Kenya** Properties for clients having already made a booking to stay with us in the month of **October 2020**.

- Providing we have received payment for your October booking or a 30% deposit, and you decide to rebook the dates of your stay with us, we wish to give you the flexibility and option of rebooking your accommodation to any date between up to **December 31st 2021 at no additional cost**. Any reductions in seasonal rate will be applied.
- This offer is subject to space availability and any 3rd party cost increases which arise from the new date of travel will be for the client's account.
- All travel arrangements booked or amended under this Flexible policy must be used by 31st October 2021. The deposit already held will be applied to the new booking dates and any balance will be payable 60 days prior to arrival.
- Bookings for Rwanda need to be dealt with on a case by case basis due to date change fees and restrictions on Gorilla permits.

PLEASE ALSO NOTE THE FOLLOWING:

- We advise all clients to take out comprehensive travel insurance. If bookings cancel then our normal terms and conditions will apply.
- In the case of an amendment, followed by a cancellation outside of our cancellation terms, we reserve the right to apply the cancellation fees from the early amendment date.
- This policy does not apply to group bookings.
